
Legionella awareness – hot and cold water systems

Course details



Tutor-led

Introduction



The legionella awareness course is designed to provide delegates with an insightful background knowledge of legionella and an appreciation of legionella to help prevent or control the risk of exposure to the bacteria within hot and cold water systems. Over two sessions, the course covers:

Key learning areas:

- What is legionella / legionellosis
- + Legal responsibilities:
 - + Applicable legislation
 - + HSE Approved Code of Practice L8
 - + HSE Technical Guidance HSG 274 parts 2 and 3
- Legionella risk assessment
- Written control scheme
- Controlling the risks within hot and cold water systems:
 - Factors that contribute to the risk of legionella bacteria within hot and cold water systems
 - + Control measures
- + Legionella sampling
- Record keeping

Who should attend?

The course is intended for those who need an understanding of legionella to help prevent or control risk of exposure to the bacteria, particularly those who need to implement and monitor precautions and keep appropriate records.

Delivery

The course is delivered remotely via on-line video sessions comprising a live presentation by the tutor supported by relevant visuals. The duration is four hours broken into two 2 hour sessions with a break between the sessions.

Delegate requirements

To attend the on-line sessions, delegates will need a computer, laptop or tablet with a working camera and microphone. Delegates are advised to test their connection before joining. Course notes and joining instructions will be provided to each delegate by email a minimum of 5 working days before the course.

Delegates are required to ensure that:

- They can enable the camera and audio from the device they are using
- They take part in the training in a quiet area with table space
- + They have their pre-course material with them
- They join each session five minutes before the start time

Assessment

At the end of the course each delegate will receive a link by email to a short open-book assessment comprising 20 questions. This will take approximately 30 minutes to complete and the pass mark is 75% (15 out of 20 questions). The cost of the course includes two attempts at the assessment.

All delegates who attend both sessions and successfully complete the assessment will be issued with a certificate of training.

Cost

The course cost is £500.00 for 6 delegates. The cost for each additional delegate to a maximum of 12 is £30.00. The cost includes all course materials, assessment and certification.
