## Delegate entry requirements

### Training venue requirements

A training venue with power and table space for each candidate. We also require a screen to project onto or TV to connect to. Delegates can expect to spend one day in the training venue and one day completing the practical elements.

For the practical element we require the use of a towing vehicle (with a competent driver), a single unit caravan in good towable condition, a suitable base, all work equipment e.g. jacks (with current certificate of examination) and levels, siting equipment including blocks, axle stands and ground boards. Personal protective equipment including protective footwear, bump cap, safety glasses or goggles and high visibility clothing will also be required for each delegate.

Arrangements for catering and refreshments will be agreed prior to the course.
